**PUBLIC HEARING ON THE PETITION TO  
OPT OUT OF 2021 SUMMER FOOD SERVICE PROGRAM  
FOR CALUMET CITY SCHOOL DISTRICT NO. 155**

The Public Hearing of South Cook Intermediate Service Center #4 and Calumet City School District No.155 was called to order by Dr. Kathleen Doyle, Assistant Executive Director of South Cook ISC#4 at 10:00 a.m. Let the record show Dr. Kathleen Doyle and Dr. Joseph H. Zotto was present.

Dr. Zotto led the Pledge of Allegiance.

Dr. Doyle outlined the reason for this Public Hearing in accordance with Public Act 095-0155 and asked the record to show that the floor was turned over to Dr. Zotto to present his Petition.

Superintendent, Dr. Zotto indicated that ISC#4 had a copy of the Petition and Affidavit in her possession already. Dr. Zotto presented the following for additional support of the Petition to Opt Out of the 2021 Summer Food Service Program in accordance with the Childhood Hunger Relief Act.

1. Notice of Public Hearing was published in the paper on November 16, 2020;
2. Notice of Public Hearing and Agenda were displayed in the normal posting position utilized by Calumet City School District No. 155 for general public viewing;
3. Based on the number of students that attended summer school in 2019 and the estimated reimbursement to be received by the School District from State and Federal sources for implementing and operating a summer food service program for the cost to the School District would be approximately \$94,943.44 in excess of those reimbursements.

Dr. Doyle opened the floor for public comment. Dr. Zotto indicated he had not received any written, email, faxed or oral requests in regards to this Public Hearing and no public was in attendance. Dr. Doyle closed the floor for public comment.
