Districtwide Parental Involvement Policy

PART I. GENERAL EXPECTATIONS

The <u>Calumet City School District #155</u> agrees to implement the following statutory requirements:

- The school district will put into operation programs, activities and procedures for the involvement of parents in all of its schools with Title I, Part A programs, consistent with section 1118 of the Elementary and Secondary Education Act (ESEA). - Audit results and surveys will be analyzed. Results will be distributed at "Principal's Prime Time" meetings
- Parents will be given results of data analysis to give feedback as to how to make improvements to the existing parental involvement policy.

 - → A series of parental workshops are held yearly at each building and parents are invited to attend all of them. Topic selection is determined by analysis of data.
- B. The school district will, with the assistance of its schools, provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training, and using technology, as appropriate, to foster parental involvement, by:
 - Where appropriate (as determined by parental surveys and ISC#4 audit results), parent information/training meetings will be held to provide information and training
