Buildings and Grounds

By reworking the bids for project number 1, he advised that there should be a significant decrease in project costs, potentially 20%-30%. By tabling bids 2 and 3, the costs may be able to be reduced by aligning the projects to the new project 1 bid. It was advised that the recommendations would not have a significant impact on the remaining capital summer projects. He indicated that there would be no anticipated delay and the projects should be completed by the end of this summer.
